## **PRESIDENT'S REPORT**

### **Report on the Tenth Anniversary Commission**

President Judith Eaton reported on the work of the CHEA Tenth Anniversary Commission that held its final meeting on September 14, 2007. The commission was established by the CHEA board of directors to acknowledge and celebrate CHEA's tenth anniversary year (1996-97). It served as a national forum for discussion of major accreditation issues and provided oversight for the forthcoming CHEA tenth anniversary publication, CHEA Report on Accreditation: Focus on the Future (working title), to be released in late 2007.

### **Report on 2006-2007 Organizational Goals**

President Eaton highlighted a number of key activities during 2006–07, including the CHEA Tenth Anniversary Commission, work on accreditation issues in the reauthorization of the Higher Education Act, activities related to the Commission on the Future of Higher Education and CHEA membership development efforts.

### **Government Affairs**

Vice President for Government Affairs Jan Friis reported on recent activities related to federal policy and accreditation. With regard to the ongoing reauthorization of the Higher Education Act, the Senate passed its bill in July 2007 (S. 1642) and the House of Representatives has yet to introduce any legislation. The current Senate is more favorable for accreditation than prior bills, but concerns remain with regard to a number of provisions. CHEA is working with the House Committee on Education and Labor as it develops a bill. A date is not established, although there has been discussion of introduction in October or November, 2007. The current Higher Education Act expires on October 31, 2007.
