## PURPOSE OF MEETING AND EXPECTED RESULTS

The meeting, organized by the Council of Independent Colleges, the Council for Higher Education Accreditation, and the Hollings Center for International Dialogue, will explore quality assurance, accreditation and higher education in Malaysia, Oman, and the United States as well as the Arab region and Southeast Asia, to enhance shared understanding especially with regard to international activity.
