Prior Recognition Action

Date: CHEA Board of Directors Meeting, January 25, 2021

Decision: Extension of term of recognition from December 31, 2022 to June 30, 2023 assuring continuity of CHEA recognition to allow for completion of the recognition process.

Summary of Prior Recognition Decisions

CHEA Board of Directors Meeting, January 29, 2018: Approved a request in the CHEA recognized scope of recognition.

<u>CHEA Board of Directors Meeting January 24, 2011</u>: The CHEA Committee on Recognition and the Board of Directors reviewed the International Fire Service Accreditation Congress – Degree Assembly (IFSAC-DA) for recognition. The review was based on the six CHEA recognition standards that require an accrediting organization to show that its accreditation process advances academic quality, demonstrates accountability, encourages self-scrutiny and planning, employs fair and appropriate procedures, demonstrates ongoing review of practice, and that it possesses sufficient resources to carry out its accreditation processes (2006 CHEA Recognition Policy and Procedures, Paragraphs 12A-12F, pp. 5-8.)

IFSAC-DA demonstrated that it meets these standards and that its accreditation process is consistent with the quality, improvement and accountability expectations that CHEA has established.

Additional Determination

IFSAC-DA is required to provide a report on the implementation of accreditation standards or policies that call for institutions or programs routinely to provide reliable information to the public on their performance, including student achievement as determined by the institution or program (Paragraph 12(B)(1), 2006 CHEA Recognition Policies and Procedures).

The CHEA recognition policy requires that an accrediting organization undergo a recognition review least every 10 years and submit two interim reports.
