• CHEA kept its recognition review of accrediting organizations strong, as part of our work to build trust and confidence in peer review as central to higher education quality.

CHEA is there for accreditation because institutions are there for CHEA. I thank all of you who have supported CHEA not only through your membership but through your active involvement. While I will no longer be CHEA's president, I will continue to serve in a consulting capacity as President *Emeritus*. And I am certain that CHEA's mission and activities will be ably advanced by CHEA's new president, Cynthia Jackson-Hammond.

2019-2020: A YEAR OF CHALLENGES, A YEAR OF ACCOMPLISHMENTS

RESPONDING TO THE NEEDS OF MEMBERS AND ACCREDITATION DURING THE COVID-19 PANDEMIC

The COVID-19 pandemic affected all of higher education as institutions moved to distance learning and accrediting



organizations kept pace with changes to the colleges and universities they oversee. CHEA, in turn, responded by assuring that

institutions and accreditors had the information they needed on changes to regulatory policy and accreditation practices.

• CHEA provided information on its Website to assist institutions in addressing the challenges of COVID-19, including U.S. Department of Education (USDE) guidance on accreditation and academic flexibility and a listing of accreditation policy statements put out by institutional and programmatic accrediting organizations.

• CHEA held a series of conference calls with CHEA- and USDE-recognized accrediting organizations on their response to the COVID-19 pandemic and hosted a Webinar on higher education and quality in Fall 2020.

• CHEA kept members informed of the latest regulatory and policy news concerning COVID-19 through a series of CHEAmails.

• CHEA joined with Tuscany Strategy Consulting and Johns Hopkins Center for Health Security to create tools designed to assist institutions with operations while the COVID-19 pandemic persists (OpenSmartEDU.org).

PROVIDING GOVERNMENT AFFAIRS LEADERSHIP

CHEA's work with Congress and the U.S. Department of Education was an important component of our efforts on behalf of higher education accreditation in 2019-2020, particularly during the COVID-19 pandemic.

• Throughout the year, CHEA met with key Congressional staff and USDE accreditation leadership on a range of policy and regulatory issues related to accreditation.

• CHEA signed more than 25 community letters to Congress and the Administration on issues including higher education funding, visas, regulations and waivers of regulations as a result of the COVID-19 pandemic.

• CHEA's Federal Update kept members informed on the latest news and events related to the federal

government and

Congressional staff addressed and participated in CHEA meetings including the 2020 CHEA Annual Conference and 2020 CHEA Summer Roundtable.

KEEPING ACCREDITED COLLEGES AND UNIVERSITIES AND THE ACCREDITATION COMMUNITY INFORMED ON THE LATEST ISSUES AND NEWS

While the COVID-19 pandemic overshadowed other accreditation-related issues in the second half of the year, CHEA



remained active addressing a range of issues affecting higher education quality, accreditation and quality assurance around the world

• As part of its National Quality Dialogue, CHEA published an *Opinion Editorial Series* on

issues related to higher education quality and accreditation and held interviews with institutional presidents on quality and accreditation.

• An issue of *Inside Accreditation*, authored by CHEA President Judith Eaton, explored the topic of rethinking accreditation and quality assurance.

• CHEA's Website resources on Accreditation and Higher Education Act Reauthorization were updated regularly.

PROMOTING HIGHER EDUCATION QUALITY THROUGH CHEA RECOGNITION

An important part of CHEA's wok in 2019-2020 was the recognition of regional, national career-related, national faithrelated and programmatic accrediting organizations.

• In response to the COVID-19 pandemic, CHEA provided flexibility to

accrediting organizations to participate in virtual recognition reviews.

• In 2019-2020, CHEA's Committee on Recognition either made recommendations to the CHEA Board of Directors or took action affecting a number of CHEA-recognized accrediting organizations. Most of the actions or recommendations involved review of interim, progress or follow-up reports that the committee had requested of the accreditors.

• The Committee on Recognition received several applications for recognition from accrediting organizations not previously recognized by CHEA.

SERVING AS A THOUGHT LEADER, CONVENER AND POLICY PARTNER ON INTERNATIONAL QUALITY ASSURANCE ISSUES

Quality

assurance bodies, higher education institutions and associations from around the world continue to support the CHEA International Quality Group (CIQG) through their CIQG membership.



Abdullatif Alshami, President and CEO, Higher Colleges of Technology; Sonya Christian, President, Bakersfield College; and Joaquin A. Guerra-Achem, Vice President for Educational Innovation and Academic Affairs, Technológico de Monterrey, received the 2019 CIQG Quality Award on behalf of their institutions.

• The CHEA/CIQG Webinar and Podcast series produced a series of Webinars on higher education quality and quality assurance and a Podcast on the digitization of higher education and quality assurance.

• CHEA/CIQG maintained and updated a Resources on Combatting Academic

Corruption section on the CHEA Website.

• The 2019 CIQG Quality Award was presented to three institutions at the 2020 CIQG Annual Meeting, to recognize higher education providers worldwide for their outstanding performance in meeting the CIQG International Quality Principles established in 2015.

INFORMING THE PUBLIC ABOUT THE IMPORTANCE AND VALUE OF ACCREDITATION

CHEA's Website, along with social media outreach through Facebook, Twitter, YouTube and LinkedIn, served as "Accreditation Central," informing students, parents and the public about accreditation and its value to society.

• The Database of Institutions Accredited by Recognized U.S. Accrediting Organizations was visited by more than 750,000 individuals in 2019-2020, providing information on the accredited status of colleges and universities

• The CHEA Website also provided indepth information about accreditation through publications and videos such as *Accreditation and Its Value to You* also found on YouTube.

• Throughout the year, CHEA posted hundreds of times on Facebook, Twitter and LinkedIn, providing information and updates on accreditation-related news and events.



The 2020 CHEA Annual Conference and CIQG Annual Meeting brought together more than 300 participants from across the United States and around the world.
