### PRESIDENT'S REPORT

President Eaton introduced Judith Watkins, Interim Vice President for Recognition Services. President Eaton presented the 2013-2014 organizational goals and budget that address the Council for Higher Education Accreditation's (CHEA) major function areas of government affairs, recognition, membership services and international quality assurance.

#### **Government Affairs Report**

CHEA Vice President for Government Affairs Jan Friis reported that the chairs and ranking members of the House of Representatives education committee and the higher education subcommittee are soliciting public comment on the Higher Education Act (HEA) as part of initiating work on reauthorization of HEA. The United States Department of Education (USDE) has announced a series of negotiated rulemakings on affordability, quality and completion following regional meetings to be held in spring 2013. The rulemaking will begin in fall 2013. Vice President Friis also reported that, following the reference to a new, alternative accreditation system in the accompanying document to the State of the Union address, the President' Budget for 2014 also included reference to exploring new validation systems that would address value and affordability in higher education as an alternative to incorporating these measures into the current accreditation system.

The next meeting of the CHEA Board of Directors will take place September 23-24, 2013 in Washington, DC.
