

BOARD OF DIRECTORS MEETING

TUESDAY, APRIL 29, 2014 WASHINGTON, DC

 - Southern Association of Colleges and Schools Commission on Colleges

PRESIDENT'S REPORT

President Eaton presented and the board approved the 2014-2015 organizational goals and budget that address CHEA's major function areas of government affairs, recognition, membership services and international quality assurance.

Government Affairs Report

CHEA Vice President for Government Affairs Jan Friis reported that the U.S. House of Representatives Committee on Education and the Workforce completed its fourteenth hearing and will begin drafting language for a bill to reauthorize the Higher Education Act later this year. Senate Democrats are beginning to draft language as well. Mr. Friis also discussed three pieces of legislation related to: 1) developing federal or national minimum accountability standards for colleges and universities, 2) establishing a federal committee for proprietary higher education oversight and 3) outlining federal transfer of credit requirements among in-state public institutions. Vice President Friis reviewed the current negotiated rulemaking for both gainful employment and state

authorization for distance education and foreign locations. He reported that CHEA is working with the Task Force on Government Regulation of Higher Education on accreditation issues, that the U.S. Department of Education has announced plans to issue new rules concerning teacher preparation programs and that two California bills that will affect the state-accreditation relationship have been introduced in the state legislature.

The next meeting of the CHEA Board of Directors will take place September 29-30, 2014 in Washington, DC.
