PRESIDENT'S REPORT

Government Affairs Report

Council for Higher Education Accreditation (CHEA) Vice President for Government Affairs Jan Friis reported on the President's proposal for a College Ratings System and the potential impact on accreditation. He informed the Board that CHEA had hosted an informal meeting with United States Department of Education (USDE) and accrediting organizations to discuss the proposed ratings system. He also discussed the U.S. Senate and House of Representatives hearings on multiple topics, including accreditation, in preparation for the upcoming reauthorization of the Higher Education Act (HEA) and reported that CHEA had participated in a briefing for staff of the Senate Health, Education, Labor and Pensions (HELP) Committee. The Board was informed that CHEA has been asked to serve on a subcommittee on accreditation for the Senate Task Force on Government Regulation of Higher Education. USDE's negotiated rulemaking on gainful employment and state authorization is continuing.

CHEA International Quality Group Update

President Eaton updated the board on the goals and targets of the CHEA International Quality Group as well as the meeting of the CIQG Advisory Council to be held on January 31, 2014.

2014 Annual Conference and CIQG Annual Meeting

President Judith Eaton provided information about the 2014 Annual Conference and CIQG Annual Meeting to be held immediately following the board meeting.

The next meeting of the CHEA Board of Directors will take place April 28-29, 2014 in Washington, DC.
