#### PRESIDENT'S REPORT

#### Government Relations

The board of directors heard an update on the current status of reauthorization of the Higher Education Act as this relates to its accreditation provisions. The House of Representatives has passed its reauthorization bill, HR 609. The Senate reauthorization bill (S. 1614) has been passed by the Health, Education, Labor and Pensions (HELP) Committee, but has not yet gone to the Senate floor. Accreditation issues related to transfer of credit, religious mission, due process and right to counsel, student achievement and disclosure have yet to be decided.

## 2006-2007 Organizational Goals and Budget

The board of directors approved the 2006-2007 CHEA organizational goals and budget. Reauthorization of the Higher Education Act and related public policy issues remain central to CHEA's work. The goals include activities related to CHEA's tenth anniversary and efforts to bring together key leaders in higher education, accreditation, business, government and the public to focus on the future of accreditation. The goals also include three major priorities for the year: (1) accountability and accreditation's responsibility to serve the public interest; (2) presidents and the public policy roles of accreditation; and (3) international quality review.
