**Summary of Major Actions and Discussion**

*(These are not official minutes of the CHEA Board of Directors.)*

Chair Dottie King called the meeting to order at 1:01 p.m.

**Treasurer's Report**

The board of directors:

- Received the FY25 third quarter financial report.
- Received an update on FY25 institutional membership.

**Working Session**

During the Working Session, President Jackson Hammond discussed current CHEA initiatives and opportunities for FY26. She highlighted a potential Quality Assurance Regional Center (QARC) collaboration with Prince Sultan University. She informed the committee that the first international accrediting organization is up for board approval of CHEA recognition.

**Government Affairs Report**

Senior Vice President Jan Friis reported that President Trump Executive Orders regarding higher education accreditation and winding down the U.S. Department of Education (USDE) operations as quickly as possible.

The U.S. Department of Education announced initial actions to comply with President Trump's Executive Order instructing USDE to allow institutions to change accreditors and begin reviewing new accreditors more freely. If the Department does not approve a change in accrediting organization within 30 days of the date of receipt of a complete notice of this change and materials the change is deemed approved.

Friis stated that the President cannot close the USDE without passing legislation in Congress to eliminate the agency, which is unlikely to pass in the Senate.

Linda McMahon was confirmed as the Secretary of the U.S. Department of Education (USDE). One of her first actions was to institute a reduction in force, impacting nearly 50% of USDE employees.
