

BOARD OF DIRECTORS MEETING

WONDAY, OCTOBER 5, 2020 VIRTUAL MEETING 3:00 p.m. – 4:30 p.m.

Summary of Major Actions and Discussion

(These are not official minutes of the CHEA Board of Directors.)

Chair Orlando Taylor called the meeting to order at 3:02 p.m.

TREASURER'S REPORT

The board of directors:

- Received the FY20 external audit as presented.
- Received the FY20 fourth quarter financial report.
- Received an update on FY20 institutional membership.

CHAIR'S REPORT

During the Working Session:

Board Chair Orlando Taylor introduced new CHEA President Cynthia Jackson-Hammond and welcomed four new board members.

The board of directors extended the term of recognition for the Commission on Opticianry Accreditation (COA) and the Accrediting Commission for Community and Junior Colleges Western Association of Schools and Colleges (ACCJC) from December 31, 2020 to June 30, 2021.

Government Affairs Report

Senior Vice President for Government Relations Jan Friis reported that the Covid-19 pandemic has dominated agendas in Washington and that there is continued work on another stimulus package. CHEA continues to work with other higher education associations to advocate for Covid-19 assistance for students and institutions, sending community letters to Congress and several federal agencies. He also reported that the U.S. Department of Education (USDE) has extended waivers for distance education and accreditation visits to institutions and accrediting organizations through the end of the year, to help institutions and accreditors meet the challenges facing higher education. USDE published in the Federal Register its final Distance Education and Innovation regulation and rescinded outdated USDE guidance documents. Friis reported that Senator Alexander is working to get an agreement on a scaled down Education Bill concerning FASFA reform, which may happen during the Lame-Duck session. He informed the board that there has been not progress on the College Affordability Act.

President's Update

At the Working Session, President Cynthia Jackson-Hammond reported on CHEA's goals and priorities for 2020-2022. They identified three main priorities – 1) assessment of existing framework of

operations; 2) membership development in a pandemic environment; and 3) CHEA mission and organizational structure.

President Jackson-Hammond announced that the 2021 CHEA Annual Conference will be virtual and take place January 26-28, 2021.

Eric Selwyn, Membership and Information Administrator, provided a membership analysis report and Lori Schroeder, Vice President for Recognition Services, reviewed the application process for CHEA recognition.

CHEA's board of directors announced a proclamation to Dr. Judith Eaton bestowing her the title of President *Emeritus*.
